## **Guidelines and Eligibility Requirements for Scholarships.**

1. The PESA (Qld) Scholarship will be granted annually to a student enrolled at a Queensland University to undertake a B.Sc. (Hons) or M.Sc. in the field of Petroleum Geology or Geophysics. A mid-year entry Honours student may apply in their first or second year, but funding in the first year will be contingent on the proposed project being taken up. An unsuccessful application in the first year will limit their ability to apply in the second year.
2. Scholarships will be in the form of a single payment of \$2,000 to the successful applicant.
3. Applications may be posted to Rachel Kieft, PESA (Qld) Scholarship Sub-Committee at GPO Box 2323 Brisbane Qld 4001, prior to Wednesday 26 September 2018. It is anticipated that the scholarship would be awarded in October.
4. The recipient shall either be a current student member of PESA or make an application for membership with their application for the scholarship.
5. One of the selection criteria used by the Sub-Committee will be that the project undertaken by the applicant must be relevant to the field of petroleum geology and geophysics and have an emphasis on practical or applied research.
6. Recipients will need to have a strong record of academic achievement to be successful.
7. On completion of the project, an abstract will be published in 'PESA News' and it is expected that a presentation will be made at a PESA (Qld) Technical Meeting.
8. As the presentation and abstract are requirements for the award of the scholarship, it is necessary that students who have company support for their projects gain approval from their company supervisors prior to application. A signed statement from the company stating that they are willing to permit a public presentation and abstract at the end of the project must be produced before the award can be made.
9. PESA (Qld) reserves the right not to award a scholarship if the Sub-Committee feels that there are no suitable applicants.
